AGREEMENT

This agreement is made this ____ day of _____, _____
Between Kathy & Dave Musto, doing business as Safari Handling and Training LLC (hereinafter
“Handler”), and _____ (hereinafter “Owner of Responsible Person”)

PURPOSE OF AGREEMENT. The purpose of this agreement is to state the duties and obligations of Handler and Owner or Responsible Person, respectively, concerning the placing of the described dog with Handler to be shown at dog shows licensed, sanctioned, or recognized by the American Kennel Club or any other organizational dog show which Owner or Responsible Person have specified. Dog entering any and all training sessions or programs both at the training center and at handler’s residence.

TERM OF AGREEMENT. This agreement shall continue in force until such time as it is terminated in writing by either party. In event either party chooses to terminate this agreement, written notification shall be made to the addresses described above with all fees for full term being paid in full at time of termination. Term of this contract starting on _____ through _____

HEALTH AND CARE OF DOG. Owner or Responsible Person agrees to be held financially responsible for all medical bills obtained while in the care of Handler. All medical attention and necessities are at the discretion of Handler. Owner or Responsible Person agrees to have the dog’s health records up to date the entire time the dog is shown or in the care of Handler. All Veterinary care will be billed to the Owner or Responsible Person for said dog.

INDEMNIFICATION AND HOLD HARMLESS. Owner or Responsible Person hereby agrees to indemnify and hold harmless Handler, or Handler’s duly authorized agent, from any and all liability for or which may result from, the following: execution of entry forms for dog shows; transportation or housing of the Dog; any injuries inflicted by the Dog on other animals, on Handler, on Owner or Responsible Person, or on third parties; and any injuries which may be suffered by the Dog, including disability, disease, or death from any cause, including but not limited to running away, theft, fire, injury inflicted by third person, and obtaining veterinary care for the Dog as specified herein. It is the express intention of the parties to this agreement that Handler shall not be held liable to Owner or Responsible Person or to any third party or parties, for any acts of the Dog, no matter the circumstances, and Owner or Responsible Person personally agrees to be liable to Handler for any such liability Handler may incur.

SHOW AGREEMENT. When Owner or Responsible Person ask/hires Handler to show the dog at a given show, the Owner or Responsible Person is then committed to that show. Therefore, if Owner or Responsible Person cancels after the closing date of that show, or is a no-show they are responsible for full payment of handling fees and agreed expenses to Handler. When Owner or Responsible Person ask/hires Handler to a specific show, where special arrangements have been made, Owner or Responsible Person is solely responsible for all handling fees and expenses listed below. Special arrangements for show include but are not limited to; National Specialties, Regional Specialties, Westminster and any other AKC recognized show or event where Owner or Responsible Person has asked/hired Handler to attend. When requesting Handler to attend a show under special arrangements where Handler has chosen, previous to show, to arrange to show other dogs all expenses are divided evenly. In this case, ring-side pick ups are not included in agreement. For any reason the Handler can not make the ring time at any event/show, a substitute handler will be recruited by the Handler for the said dog, all fees apply.

EXPENSES FOR SPECIAL ARRANGEMENTS. Travel; gas, air flight (round-trip). Hotel; chosen by Handler. Food; three meals per day. Admission/Ticket fees, Rental car fees. Owner or Responsible Person agrees to pay all traveling expenses incurred to Handler while in route to or at the show.

FEE PAYMENT. Owner or Responsible Person agrees to pay in full all handling and boarding fees for services provided by the Handler at the completion of a show weekend. Special billing must be in written agreement of Handler and Owner or Responsible Person, prior to services provided by Handler. Full payment for services must be made within 30 days of bill. After the 30 days a 25% increase will occur per day over due. \$1,000 deposit will be required for all dogs arriving to live at Safari Handling and Training LLC over 2 weeks, the deposit being applied to final bill.

DISPUTES. This agreement is to be construed to the laws of the State of Ohio. The parties agree that in the event of a lawsuit arising out of this contract, suit must be initiated in the courts of Delaware County. Owner or Responsible Person further agrees that he or she is subject to the jurisdiction of the courts of Delaware County, Ohio and hereby waives any defense he or she has or may have to suit in Delaware County, Ohio based on an alleged absence of in personal jurisdiction. This agreement is binding on the heirs, assigns, agents, and legal representative of the parties hereto. Owner and/or Responsible party is responsible for all attorney fees incurred by Handler if lawsuit occurs related to this contract.
